

1 DEFINITIONS

In this Agreement, the following expressions shall have the following meanings: "Annual Maintenance Support Plan" - Means the Software technical support activities made available by Famic to Licensee on an annual basis. This includes new version updates, error fixes, Software and Documentation enhancement, remote technical support by telephone, fax or through Internet. This expressly excludes: training, remote or on-site Software installation, Software customization, operational environment installation and configuration (operating system, database, Local Area Network, etc.), which can be offered by Famic at the then applicable Famic's rates.

"ASEE" - Means Automation Studio Educational Edition.

"ASPE" - Means Automation Studio Professional Edition.

"Documentation" - Means the User's Manuals, as well as all documentation that Famic shall remit to Licensee from time to time with regard to the use of the Software and proper exploitation of the

"EUSLMA" - Means the present Automation Studio End User Software License and Maintenance Agreement applicable to the use of the Software.

"Famic" - Means Famic Technologies Inc.

"Intellectual Property Rights" - Means all the rights, titles and interests, including copyrights and patent rights, as well as trademark rights, goodwill, trade secret, know how, and moral rights, in Canada.

"Licensee" - Shall mean the Registered User as identified on the returned Registration Form or via the Internet.

"Network License" - Means an Automation Studio license to be used on a Local or Wide Area Network (LAN / WAN) by two or more Licensees as agreed upon and authorized by Famic.

"Party" - Means either Famic or Licensee.

"Problem" - Means a Software behavior, diagnosed by Famic, which does not substantially conform to the Software documentation under normal use of the Software and on a common hardware, operating system and network configuration.

"Protection Key" - Means that hardware device delivered with the copy of the Software intended to protect against illegal copying and unauthorized use besides Licensee.

"Registration Form" - Means the Automation Studio Registration Form shipped with the Software and Documentation in order to be filled out by Licensee and returned back to Famic. The Registration Form states complete Licensee coordinates, Licensee's company information, Automation Studio license number(s) and operation environment information. The Registration Form can be completed online using the Web site: https://support.famictech.com.

"Software" - Means Automation Studio software V5.7 and higher identified by copy Number(s) listed in the Registration Form. The Software is contained on the Software's CD-ROM / DVD-ROM and Protection Key including Software program(s), libraries or files in machine readable form, parameters, configuration data, instruction manuals, user manuals and other information relevant to such Software developed by Famic and any improved, modified or corrected versions of them.

"Technical Support Contact" - Means the Licensee or the individual designated by Licensee in order to represent Licensee in contacts with Famic relating to Automation Studio's technical support. Technical Support Contacts are considered technically competent and able to communicate. They are able to implement instructions supplied by Famic to the Software and/or operational environment configuration. The number of Technical Support Contacts is normally limited to one (1) per Software License. Famic and Licensee can agree on a higher number of Technical Support Contacts depending on the quantity of installed Software Licenses and their geographical locations

"User's Manuals" - Means the written documentation provided by Famic with the Software in order to explain its installation, operation, maintenance, etc.

"Vendor" - Means an Automation Studio vendor or reseller, duly authorized by Famic.

"Workaround" - Means a change in the way of operating the Software or in the procedures followed by Licensee, which allows avoiding a Problem.

2 GRANT OF LICENSE TO USE

IN CONSIDERATION OF payment of the License fees, and Licensee's acceptance of all of the terms and conditions of this EUSLMA, Famic grants Licensee a non-exclusive, non-transferable, perpetual License to use the copy of the Software and Documentation and subject to the accompanying documentation.

3 OWNERSHIP AND LIMITED TITLE WARRANTY

Famic holds and retains all Intellectual Property Rights attached to the Software and Documentation, regardless of the form or media in or on which the original Software and Documentation and other copies may exist. This EUSLMA is not a sale.

Famic represents and warrants that: (i) the Software and Documentation have been entirely conceived, created and written by Famic; and that (ii) to the best of its knowledge, after reasonable investigation, Software and Documentation do not violate any Intellectual Property Rights of any third party in Canada. If the Software and Documentation supplied under this EUSLMA are in Famic's opinion likely to or does become the subject of a claim of copyright or trademark infringement, Famic may, at its own discretion and expense, procure for Licensee the right to continue using the Software and Documentation, modify the Software and Documentation to make them non-infringing, or substitute the Software and Documentation with other software and documentation of similar capability. If, in Famic's opinion, none of these alternatives is reasonably available, Famic may terminate the license of the Software and Documentation upon thirty (30) days' written notice to Licensee and proceed to a reimbursement of the Software and Documentation according to the conditions set out in Section "5 LIMITATION OF LIABILITY". Famic shall not consider any of the above remedies for or in respect of a claim for infringement:

- If the claim is based on the use of the Software in combination with software or data not provided by Famic, and infringement could have been avoided by the use or combination of the unaltered Software with any other programs or data; or
- If the infringement could have been avoided by the use of the current unaltered release of the 2.
- If Licensee has any direct or indirect interest by license or otherwise, apart from this License, in the claimed infringement of patent of copyright.

THE ABOVE SHALL CONSTITUTE THE ENTIRETY OF THE TITLE WARRANTY GIVEN TO LICENSEE BY FAMIC WITH REGARD TO SOFTWARE AND DOCUMENTATION

4 LIMITED PERFORMANCE WARRANTY

This Limited Performance Warranty shall not apply to any Software or Protection Key that may have been subjected to abuse, accident or disaster, or that may have been modified by the Licensee or used in a manner contrary to the instructions in effect pertaining to its installation, maintenance or operation, or contrary to industry standards or the provisions of this EUSLMA.

No oral or written information or advice given by Famic, its dealers, distributors, agents or employees, shall create a warranty or in any way increase the scope of this Limited Warranty and Licensee may not rely on any such information or advice.

4.1 Media

Famic warrants that, for a period of thirty (30) days from the date of shipment from Famic, as evidenced by the date of the original invoice for the Software, the media on which the Software is recorded, the CD-ROM / DVD-ROM and the Protection Key are free from defects in material and workmanship under normal use and service.

Famic's entire liability and Licensee's exclusive remedy as to the CD-ROM / DVD-ROM and the Protection Key shall be, at Famic's sole and exclusive option, either:

Refund the purchase price;

Free of charge replacement of the CD-ROM / DVD-ROM and/or the Protection Key which do not (b) meet the Famic Limited Warranty and which is (are) returned to Famic prepaid by the Licensee.

If in Famic's opinion the failure of the CD-ROM / DVD-ROM or the Protection Key has resulted from accident, abuse, or misapplication, Famic shall have no responsibility whatsoever. Famic can replace the defective CD-ROM / DVD-ROM and/or the Protection Key and Licensee agrees to pay the applicable charges for such service.

In any case, the defective media must be first shipped by Licensee and received by Famic in order for Famic to ship a replacement.

The replaced CD-ROM / DVD-ROM and/or Protection Key will be warranted for a period of thirty (30) days, from the date of shipment.

4.2 Lost Protection Keys

The Protection Key is essential for the Software to run. Should the Protection Key get lost, Licensee must repurchase a new license. Using a Protection Key that was already declared lost may lead to unpredictable results.

4.3 Software Program

Famic warrants to Licensee that the User's Manuals are substantially complete and contain information which Famic deems necessary for use of the Software.

The Software functions substantially as described in the User's Manuals for a period of three (3) months after their delivery by Famic provided that:

- The Software is installed according to Famic's procedures and instructions; Licensee has promptly applied all service releases and problem fixes made available by Famic; (b)
- The Software is operated in compliance with and according to Famic's procedures, instructions (c) and Documentation;
- The Software is used by sufficiently competent and trained personnel; (d)
- Licensee has notified Famic of any defect or problems within thirty (30) days after the Software and Documentation were delivered to Licensee by Famic

Following the receipt of Licensee's written notice as explained in paragraph (e) above and provided that Licensee supplies all the assistance required to Famic in order to diagnose the problem, Famic, at its sole and exclusive option, will use commercially reasonable efforts during normal business hours to fix the Software and Documentation, exchange the Software and Documentation, provide a workaround for the Software and Documentation or refund the Software and Documentation as set in Section "5 LIMITATION OF LIABILITY"

Notwithstanding any other provision of this EUSLMA, the warranty above constitutes the only recourse available to Licensee in case of defective Software and Documentation. Replacement Software and Documentation shall be warranted as above.

4.4 Disclaimer

FAMIC SUPPLIES THE SOFTWARE AND DOCUMENTATION "AS IS" AND DOES NOT WARRANT THAT THEY WILL MEET YOUR REQUIREMENTS, BE ERROR FREE OR THAT ALL ERRORS WILL BE CORRECTED.

EXCEPT AS PROVIDED IN THIS EUSLMA, FAMIC DISCLAIMS ALL EXPRESSED AND/OR IMPLIED WARRANTIES AND CONDITIONS PERTAINING IN ANY WAY TO THE SOFTWARE AND DOCUMENTATION, INCLUDING WITHOUT LIMITATION, SATISFACTORY QUALITY, ANY WARRANTY AND / OR CONDITION OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, WHETHER EXPRESSED OR IMPLIED BY STATUTE, COMMON LAW, USAGE OF TRADE, COURSE OF DEALING, CUSTOMER OR OTHERWISE. FAMIC DOES NOT WARRANT THAT THE SOFTWARE WILL INTEGRATE ERROR-FREE WITH ALL THE OTHER SOFTWARE RUNNING ON YOUR SYSTEMS.

5 LIMITATION OF LIABILITY

Famic's total cumulative liability (if any) to Licensee or any third party for damages arising out of or in connection with this EUSLMA and the provision of the Software and Documentation by Famic or any Famic's third party provider will in no event exceed the total in aggregate of all amounts paid by Licensee to Famic under this EUSLMA amortized over a four (4) years period. Licensee's sole and exclusive remedies in respect of the Software and Documentation shall be as stated in this EUSLMA.

UNDER NO CIRCUMSTANCES WILL FAMIC OR ANY OF FAMIC'S THIRD PARTY PROVIDER BE LIABLE TO LICENSEE OR ANY THIRD PARTY FOR ANY INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, EXPENSES, COSTS, LIABILITY OR LOSS WHATSOEVER, INCLUDING BUT NOT LIMITED TO LOST PROFITS, LOST REVENUE, LOST DATA, REPLACEMENT COSTS, LOSS OF USE OF ANY INFORMATION SYSTEM, FAILURE TO REALIZE EXPECTED SAVINGS OR ANY OTHER COMMERCIAL OR ECONOMIC LOSS, WHETHER ARISING IN TORT, NEGLIGENCE, STAT-UTE, EQUITY, CONTRACT, COMMON LAW, OR ANY OTHER CAUSE OF ACTION OR LEGAL THEORY EVEN IF FAMIC HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS OR DAMAGE.

LICENSEE AGREES, ACKNOWLEDGES AND CONFIRMS THAT THE LIMITATIONS OF LIABILITY SET OUT IN THIS EU-SLMA ARE FAIR AND REASONABLE IN THE COMMERCIAL CIRCUMSTANCES OF THIS EUSLMA AND THAT FAMIC WOULD NOT HAVE ENTERED INTO THIS EUSLMA BUT FOR LICENSEE'S AGREEMENT TO LIMIT FAMIC'S AND THIRD PARTY PROVIDERS' LIABILITY IN THE MANNER AND TO THE EXTENT PROVIDED FOR HEREIN.

This Section applies even in the event of a breach of condition, a breach of an essential or fundamental term, or a fundamental breach of this EUSLMA.

6 RESTRICTIONS

Unauthorized copying of the Software and Documentation in total or in part, including software that has been modified, merged or included with other software or the written materials, is expressly forbidden. Licensee may be held legally responsible for any infringement, which is caused or encouraged by Licensee's failure to abide by the terms of this Agreement.

You may not modify, adapt, translate, reverse engineer, decompile, disassemble or create derivative works based on the Software, or the written materials, remove or modify any notice of intellectual property, copyright, logo or marking.

7 TRANSFER

This copy of the Software and Documentation is licensed only to Licensee, and may not be transferred to anyone else. In no event may Licensee assign, transfer, rent, sublicense, lease, sell or otherwise dispose

of the Software on a temporary or permanent basis except as expressly provided herein.

As licensee, Licensee may uninstall the Software from one computer and reinstall it on another one. The Software shall only be used on one computer at a time.

8 NETWORK LICENSE

If Licensee has purchased a Network License, Licensee may not run copies of the Software on more computers than the number specified in Licensee's Network License. The conditions stated in this EUSLMA are applicable to each License and to each Licensee.

9 BACKUP COPY

Subject to the restrictions set in this EUSLMA, Licensee may make one (1) copy of the Software solely for backup purposes. Licensee must reproduce and include the copyright notice on the backup copy.

10 EXPORT REGULATIONS

The Software and Documentation delivered under this EUSLMA contain elements (technical data, hardware, etc.) that are subject to Canadian and United States of America export control laws and may be subject to other export or import regulations. Licensee shall agree not to export or re export the Software and Documentation directly or indirectly to countries subject to restrictions (embargoes) imposed by the Government of Canada and/or the United States of America. Licensee agrees not to use the Software and Documentation for any purpose prohibited by these laws including without limitation nuclear weapons, chemical weapons, biological weapons, etc.

11 UPDATED VERSIONS

Famic may from time to time create updated versions of the Software and Documentation and may upon conditions that it might establish form time to time make such updates available to Licensee should Licensee have paid in advance for the Annual Maintenance Support Plan as per Section 12, and be properly registered, either by proper completion and return of Registration Form to Famic or through Internet. It is Licensee's obligation to ensure that Famic has Licensee's current address. The said updated versions do not include options, features or modules that are marketed independently from what the Licensee had purchased.

Famic may cease supporting existing Software versions used by Licensees. Non supported versions will be shown at the following Web site: http://www.automationstudio.com.

11.1 Automatic Updates

Subject to having an active Annual Maintenance Support Plan (See Section 12), Licensee can use the Automatic Update function in order to keep the installed license(s) up to date. This function checks regularly for the availability of new updates and prompts Licensee in order to install them. The following information is needed for the verification process: installed Software license(s) number(s), installed Software edition and version number, the IP address for communications. No personal information is needed in order to make the verification. Licensee acknowledges and agrees that the use of this function will enable the Software to communicate through internet with the Automation Studio™ technical support portal in order to download the updates for installation.

12 ANNUAL MAINTENANCE SUPPORT PLAN CONDITIONS

12.1 Maintenance Support Services

IN CONSIDERATION OF payment of the Annual Maintenance Support Plan fees, and Licensee acceptance of all of the related terms and conditions, Famic agrees to offer Licensee the Maintenance support services relating to the Software.

Famic agrees to devote reasonable commercial efforts within normal working hours in order to accomplish its obligations but Famic does not guarantee the end results.

Maintenance support services are available to Technical Support Contacts by telephone, fax, or Internet. They include the following:

- Answer questions relating to the operation, the installation or configuration of the Software;
- (b) Discuss the status of Problem(s) reported; (c)

Provide reasonable guidance for using the Software.

Version updates and Problems fixes will either be sent by Internet or on CDROM.

If in Famic's opinion, the difficulties reported are caused by a lack of knowledge of the Software, Famic will suggest to Licensee to attend training seminars.

Famic encourages the use of the Technical Support Portal available through the following Web site: www.automationstudio.com.

12.2 Validity

The Annual Maintenance Support Plan is valid for a period of one (1) year starting at the purchase date.

The Annual Maintenance Support Plan fees are a percentage of the current Software value. Licensee should contact Famic in order to receive a detailed quotation.

A renewal notice is sent automatically to Licensee prior to the anniversary date of the original purchase of the Annual Technical Support Plan. The renewal cost is based on the current value of the owned Software. Licensee may decide not to renew the Annual Technical Support Plan.

Renewal of an already expired Annual Technical Support Plan is subject to reinstatement fees and to payments for the lapsed period. An Annual Maintenance Support Plan that has expired for more than two years cannot be renewed. In this case, the Annual Maintenance Support Plan can be made available only with the purchase of a new license.

12.5 Maintenance Support Policies

The Annual Maintenance Support Plan is subject to Famic's technical support policies available on the following Web site: http://www.automationstudio.com. The said policies may change from time to time without prior notice.

12.6 Licensee's Obligations

Licensee acknowledges and agrees to the following:

- Install the latest Software versions released by Famic; (a)
- (b) Promptly apply all service releases as they become available;
- Operate the Software in compliance with and according to Famic's procedures and instructions (c) and Documentation:
- (d) Not to alter or modify the Software;
- (e) Report the encountered problems and difficulties in writing and in full details and provide to Famic all required assistance and information in order to diagnose the reported problems. Such information may include: screen shots, data files, log files, dumps, Protection Key content, etc.

12.7 Problem Correction

Following the receipt of Licensee's written notice reporting a problem and provided that Licensee is not in breach of this EUSLMA, Famic will use commercially reasonable efforts during normal business hours in order to correct or provide a workaround for the problem in a timely fashion. Famic will take into consideration problems reported by Licensee only if Licensee is able to reproduce them.

Correcting a problem might require development of software fixes and testing. When a problem is not critical, Licensee acknowledges and agrees that the correction of the said problem could be part of the next future version update.

The process of diagnosing a Problem reported by Licensee may lead Famic to reasonably believe that the Problem is not due to the Software and may be caused for instance by:
(a) One of the reasons as explained in Section "12.6 Licensee's Obligations";

- Non authorized action by Famic made by Licensee or a third party; (b)
- Another software not supplied by Famic; (c)
- (d)

In this case, Famic will inform Licensee and will suspend the diagnostic process. Famic will resume the process after receiving from Licensee a written notice to do so. If upon the resolution of the problem Famic determines that it is indeed not due to an error in the Software, Famic will invoice Licensee, at Famic's then applicable rates, for time and materials dedicated to the resolution of the said problem.

12.8 Altered Versions

Famic has no obligation to offer any technical support for versions of the Software altered by Licensee or any third party.

12.9 Disclaimer

14 AUDIT

To ensure compliance with this EUSLMA, Licensee agrees that upon reasonable notice, Famic or Famic's authorized representatives shall have the right to inspect and audit Licensee's installation, access, and use of Software and Documentation. Any such inspection or audit will be conducted during regular business hours at Licensee's facilities or electronically (if feasible), either by Famic or by representatives authorized by Famic for this purpose. 16 INVALIDITY

The invalidity of any particular provision of this EUSLMA shall not affect any other provision hereof.

17 LANGUAGE

The English version of this EUSLMA has precedence and is legally binding in case of inconsistencies with any of its translations.

18 COMPLETE AGREEMENT

This EUSLMA constitutes the entire understanding between the Parties in respect of the matters herein and supersedes all prior oral and written understandings, agreements and commitments.

LICENSEE ACKNOWLEDGES THAT HE/SHE HAS READ THIS EUSLMA, UNDERSTANDS EACH ONE OF ITS TERMS AND CONDITIONS AND AGREES TO BE BOUND BY THEM. LICENSEE ALSO AGREES THAT THESE TERMS AND CONDITIONS ARE THE COMPLETE AND EXCLUSIVE STATEMENT OF AGREEMENT BETWEEN THE PARTIES, AND THEY SUPERSEDE ALL PRIOR AGREEMENTS, EITHER WRITTEN OR ORAL AND ANY OTHER COMMUNICATIONS BETWEEN THE PARTIES.
